1. What information do we collect about you?

Britannia Pier (GY) Ltd Theatre takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Britannia Pier (GY) Ltd Theatre via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;

2. In this privacy policy, unless the context requires a different interpretation:
 1. the singular includes the plural and vice versa;
 2. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 3. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 4. “including” is understood to mean “including without limitation”;
 5. reference to any statutory provision includes any modification or amendment of it;
 6. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of Britannia Pier (GY) Ltd Theatre and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, Britannia Pier (GY) Ltd Theatre is the “data controller”. This means that Britannia Pier (GY) Ltd Theatre determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5. We may collect the following Data, which includes personal Data, from you:
 1. name;
 2. contact Information such as email addresses and telephone numbers;

in each case, in accordance with this privacy policy.

How we collect Data

6. We collect Data in the following ways:
 1. data is given to us by you ; and
 2. data is collected automatically.

Data that is given to us by you

7. Britannia Pier (GY) Ltd Theatre will collect your Data in a number of ways, for example:
1. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 2. when you make payments to us, through this Website or otherwise;
 3. when you elect to receive marketing communications from us;
 4. when you use our services;

in each case, in accordance with this privacy policy.

Data that is collected automatically

8. To the extent that you access the Website, we will collect your Data automatically, for example:
1. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 2. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
1. internal record keeping;
 2. improvement of our products / services;

in each case, in accordance with this privacy policy.

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

Who we share Data with

11. We may share your Data with the following groups of people for the following reasons:

1. our employees, agents and/or professional advisors – To process customers request for tickets and services;

in each case, in accordance with this privacy policy.

Keeping Data secure

12. We will use technical and organisational measures to safeguard your Data, for example:

1. access to your account is controlled by a password and a user name that is unique to you.
2. we store your Data on secure servers.

14. Data retention

15. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.

16. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

17. You have the following rights in relation to your Data:

1. **Right to access**– the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is “manifestly unfounded or excessive.” Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
2. **Right to correct**– the right to have your Data rectified if it is inaccurate or incomplete.

3. **Right to erase**– the right to request that we delete or remove your Data from our systems.
 4. **Right to restrict our use of your Data**– the right to “block” us from using your Data or limit the way in which we can use it.
 5. **Right to data portability**– the right to request that we move, copy or transfer your Data.
 6. **Right to object**– the right to object to our use of your Data including where we use it for our legitimate interests.

Changes of business ownership and control

22. Britannia Pier (GY) Ltd Theatre may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of Britannia Pier (GY) Ltd Theatre . Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
23. We may also disclose Data to a prospective purchaser of our business or any part of it.
24. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies

Britannia Pier (GY) Ltd Theatre has carefully chosen these Cookies and has taken steps to ensure that your privacy is protected and respected at all times.

27. Before the Website places Cookies on your computer, you will be presented with a message bar requesting your consent to set those Cookies. By giving your consent to the placing of Cookies, you are enabling Britannia Pier (GY) Ltd Theatre to provide a better experience and service to you. You may, if you wish, deny consent to the placing of Cookies; however certain features of the Website may not function fully or as intended.
28. This Website may place the following Cookies:

Type of Cookie	Purpose

By accepting your order a legally binding contract is created between the Britannia Pier (GY) Ltd Theatre and you. This contract shall be governed by and interpreted in accordance with English law, and the English courts shall have jurisdiction to resolve any disputes. By placing your order you warrant that all details you provide to us for the purpose of booking, ordering or purchasing goods or services are correct, that the credit or debit card you are using is your own and that there are sufficient funds to cover the cost of the ticket or service. If there are any changes to the details supplied by you it is your responsibility to inform us.

All tickets are subject to availability.

It is a condition of sale in respect of all tickets that a ticket is only valid for admission to the performance it was booked for if at no time it has been sold or exchanged at a price or value that is more than the price paid for it at the Britannia Pier (GY) Ltd Theatre Box Office. Any ticket which has been at any time sold in contravention of this condition is void and will not admit the holder to the performance.

Britannia Pier (GY) Ltd Theatre staff are authorised to refuse admission to the theatre and reserve the right to do so if in their absolute judgement your conduct is such that it is likely to disrupt or disturb other persons attending the theatre. Britannia Pier (GY) Ltd Theatre also reserves the right to terminate your permission to be on the premises and remove you therefrom in similar circumstances.

Every member of the audience must be in possession of a valid ticket. Altered or defaced tickets will not be valid.

Confirmation of receipt of your order by e-mail, does not guarantee the ticket sale (internet sales only).

Please check your tickets as mistakes cannot always be rectified. Britannia Pier (GY) Ltd Theatre reserves the right to alter or vary the performance / event due to events or circumstances beyond Britannia Pier (GY) Ltd Theatre's control without being obliged to refund monies or change tickets. This does not affect your statutory rights.

If you cannot use tickets already paid for, Britannia Pier (GY) Ltd Theatre can exchange them for another performance where available (7 days notice required). To exchange tickets, the originals must be returned to the Box Office. This service is subject to a handling charge of £2 per ticket. Except in the event of a cancellation of a performance no refund or part thereof is available after a ticket is purchased.

Possession of a valid ticket authorises admission of the holder to the auditorium immediately before the performance begins but once the performance has begun the following applies. To avoid disturbing the audience and performers, latecomers will not be allowed access to the auditorium until a suitable point in the performance designated by the company, which may not be until the interval.

The making of recordings and photography, with or without flash, is strictly forbidden.

Smoking is not permitted in Britannia Pier (GY) Ltd Theatre .

Any complaints regarding the show or view from the seats should be made to the Duty Manager promptly, prior to or during the performance.

Britannia Pier (GY) Ltd Theatre reserves the right for themselves or third parties to carry out general filming and sound recording in or around the building. Purchase of a ticket signifies the holder's consent to be photographed or sound recorded and to the commercial exploitation of such film or recording without any right to payment. Any ticket holder who objects to being photographed or recorded must advise the Duty Manager before the performance begins.

For certain shows, babies and children under 3 are welcome and may share a seat with you. For shows which do not qualify for this option, we regret children under 3 are not admitted to the auditorium.
